1. PURPOSE OF THE BID

Bid No:

The purpose for this bid is to call for service providers to be included in the SAHPRA panel of legal practitioners to render legal services to SAHPRA in the specified areas as and when required on a competitive basis.

2. BACKGROUND

The mandate of SAHPRA as a schedule 3A entity is to ensure the efficient, effective, and ethical evaluation or assessment and registration of medicines, medical devices and IVDs that meet defined standards of quality, safety, efficacy, and performance, where applicable. To ensure that the process of evaluating or assessing and registering medicines, medical devices and IVDs is transparent, fair, objective and concluded timeously.

3. SCOPE OF WORK

The legal practitioners appointed to the panel will provide quality and specialist legal services to the SAHPRA in the various areas of work specified below.

For each practice area there must be a lead practitioner as well as at least one proposed practitioner complying with the minimum requirements. The lead practitioner and the practitioner may be the same person.

i. The **minimum technical threshold is 70 points**. Bidders that do not meet the minimum technical threshold will not be eliminated from further consideration. Points will therefore not be awarded for their cost proposals or for preference.
